And, most importantly, the GU-24 base lamps can be used in luminaires intended to comply with a host of recognized energy efficiency standards and regulatory mandates, such as ENERGY STAR and California Title 24.

Great Flexibility Allows Assembly And Cost Savings

The Leviton GU-24 fluorescent series allows manufacturers to expand their lines of screwshell-base incandescent luminaires to include compact fluorescent versions without costly retooling or modification. A choice of three different mounting configurations is offered. They are designed to match common medium-base screwshell lampholder mounting styles – bracket mount, collar mount and panel mount – as well as provide additional flexibility while saving cost and assembly time. They are ideal for a wide range of product applications including residential and commercial lighting fixtures, portable luminaires and decorative wall sconces.

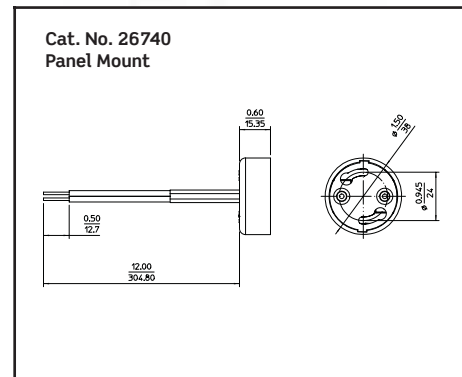
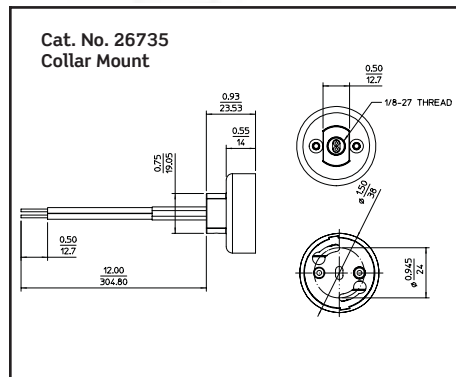
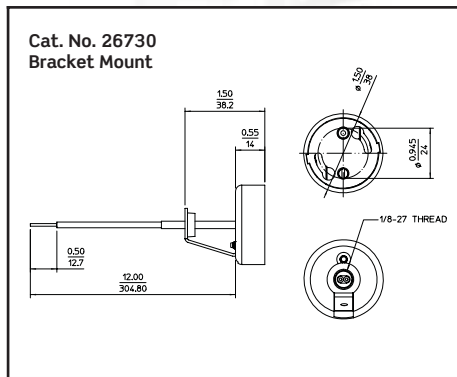
